The Subscriber(s) agrees to abide by the rules governing the Holy Family Church Columbarium, and any other applicable rules or regulations that are now or may be adopted by the church with respect to the columbarium.

The Subscriber(s) hereby relinquishes any rights against the church for damage of any sort that may occur to the niche or cremains of the applicant, or family member of the applicant, if this be the case, as a result of fire, theft, vandalism or any other event beyond the control of the church.

This Grant and Agreement are made expressly subject to all laws and ordinances and the Regulations and Conditions governing the use of the Holy Family Church Columbarium of Clarkston, WA, now and hereafter in force.

Regulations and Conditions Governing the Use of the Columbarium at Holy Family Church in Clarkston, WA

The use of the Columbarium and the allotment of niches therein are governed by Holy Family Catholic Church in Clarkston, WA are subject to the following regulations and conditions:

- 1. Assignment of niches will only be given and held for active, registered members or immediate family members of Holy Family Parish at the time of purchase of a niche(s). Or, if available, other people who are active members of the Catholic Church in other parishes will be permitted to purchase niches in the Holy Family Church Columbarium.
- 2. Immediate family members are defined as: spouse, children, siblings, parents, grandparents or grand-children regardless of religious preference.
- 3. Reservation of the right to inter in a niche in the columbarium is made when a Columbarium Contract is signed by both the subscriber and an authorized Church representative. The contract contains payment options. Upon request, if a subscriber wishes to relinquish an assigned niche, the subscriber will sell the nice back to the church and be reimbursed for payments previously made less a \$250 administrative fee.
- 4. Cremated remains may not be removed from the Columbarium without written consent of the Church and the surviving spouse or next of kin of the deceased.
- 5. There will be no opening, closing, inscription or other additional fees charged to be inurned in the Holy Family Church Columbarium.
- 6. The capacity of each niche is limited to two urns. The maximum size of the urn for the smaller niche is $8"x \, 4"/4"x \, 6"$ the size of the urn provided by the crematory. A larger urn of appropriate size may be used in the larger sized niches. The Church reserves the right to refuse to accept an urn, which in its judgement, will not provide permanent internment, or will not permit use of the niche to its stated capacity, or for any other reasonable grounds.
- 7. The use of a niche shall be limited to the cremated remains of such persons as are designated in writing at the date of issuance of the Columbarium Contract. Only the cremated remains of humans are allowed to be inurned in the columbarium.
- 8. Holy Family Church has the responsibility for choosing high quality materials, for maintaining uniformity, and for the procurement of inscriptions.
 - a. Inscriptions on the columbarium niches consist of surnames and Christian names and dates of birth and death.
 - b. Inscriptions are in a style approved by Holy Family Church.
 - c. A printing font is selected by the church and is used on all niche inscriptions.
- 9. Holy Family Church arranges for the maintenance of the Columbarium. Nothing of either a permanent or temporary nature shall be affixed to or on the Columbarium.
- 10. The rites of inurnment will be in keeping with Roman Catholic forms of worship and prescribed by the Pastor. Any exceptions require the approval of the Pastor.
- 11. The cost of cremation, urn, and any attendant cost and expense shall be the responsibility of and shall be paid by the legal or personal representative of the person to be inurned in the columbarium.
- 12. The use of any ornamentation on or proximate to any niche by any subscriber is prohibited. The Church will be responsible for plants or cut flowers or seasonal decorations at specific times during the year and arranges for the maintenance of the Columbarium.
- 13. For purposes of control and clear understanding, a Right of Inurnment shall be executed by all involved parties, including a provision granting full authority to Holy Family Church to move, remove, relocate, whether temporarily or permanently, niches with cremated remains.
- 14. In the unlikely event that moving, removing or relocating columbarium niches becomes necessary, Holy Family Church will endeavor to notify the families of the deceased of the required move.
- 15. In the unlikely event that removal and relocation of cremated remains becomes necessary, all cost associated with moving the cremated remains will be borne by Holy Family Church Columbarium and/or Holy Family Church and/or the Diocese of Spokane.

- 16. The cost of the Columbarium is paid from fees paid by those who purchase a Right of Inurnment (Columbarium Contract).
- 17. Funds received from sales will be used to pay for construction through establishment of a fund for supplies/ services and perpetual care to cover maintenance expenses and any portion of major damage done to the Holy Family Church Columbarium which is not covered by insurance.
- 18. It is understood that all of the initial funds are used to pay for the construction of the initial phase of the Holy Family Church Columbarium, the columbarium niches, the perpetual care fund and future expansion construction, in that order.
- 19. A record of the diagram of the Holy Family Church Columbarium and its niches is maintained by Holy Family Church and is available at the parish office of Holy Family Parish. The diagram is to be kept current.
- 20. The vital statistics of all person who will be or who are inurned in the Holy Family Church Columbarium is also a part of the above record. The information includes the name of the purchaser of the niches, the name and address of surviving member(s), birth and death dates, a record of membership in the Catholic Church and the fee paid for the niche.
- 21. Financial records of the Holy Family Church Columbarium are maintained in the Holy Family Parish office and a financial statement for the most current year will be available upon request.
- 22. These regulations and conditions may be altered, amended or repealed by Holy Family Church.
